



General Media Accreditation Regulations 2024

1. REGISTRATION:

Media accreditation applications will be accepted **until 14th December 2023**. Exceptions for late registration are subject to approval by Hahnenkamm Race (HKR) Organizers. Special requests with regards to technical equipment must be made at the Press Centre in good time during the registration process. (See registration form **section "H"** Press Centre <Press working area> & **section "J"** Notes).

2. ACCREDITATION REQUIREMENTS

Prerequisite for accreditation is a valid press pass, a credible intent to report from and on the sports event, as well as representation of a relevant media organisation. Press Office Management reserves the right to make restrictions or exceptions in this regard. In case of doubt, confirmation from the respective chief editor will be required by the Organizing Committee. The number of media representatives approved for accreditation is limited, the decision to confirm any accreditation request is the sole responsibility of the Organizer.

TV / FILM / RADIO / VIDEO in particular is subject to separate contractual regulations.

3. ACCREDITATION ID

Official accreditation ID for the Hahnenkamm Races entitles the holder to access the race site and designated areas (coded according to accreditation ID). These ID's are not transferable and must be shown without fail to enforcement officers within the control zones. Compliance with instructions issued by the enforcement officers is compulsory. ID holders are subject to the conditions and regulations of FIS Competition Rules and FIS World Cup Regulations, as well as the **Organiser's Rules of Access**. In particular, persons granted special "PISTE" accreditation are subject to special instructions by the jury as well as their regulatory bodies. These instructions must be complied with immediately. The number of piste accreditations for photo and TV are limited and subject to approval by the FIS Chief Race Director.

4. SPECIAL NOTE

The use of drones is strictly prohibited.

5. LEGAL NOTICE - TEXT & PHOTOS

Photos and texts about the event may be published by the accredited media | media representatives in print, online and/or other digital media services (editorial contributions only). **Images (photos)** may only be distributed for editorial contributions. Resale to third parties for advertising purposes is prohibited or, in exceptional cases, must be clarified in advance with the Organizer.

6. LEGAL NOTICE - MOVING IMAGES & SOUND

Production, transmission and distribution via the internet and other multimedia-based services, whether live or time-delayed, as a whole or parts thereof, regardless of the device (e.g. film camera, mobile phone, audio recording device, digital camera, camera, notebook, etc.) and technical process, are prohibited on the event grounds.

Exceptions to this regulation are only admissible with written consent from the Organizer and its rights partners. The contact person for television, film and radio rights is Mr. Andreas Eichwalder -

Those not wearing a TV armband will be denied access to the event grounds! This will be issued on accreditation.

7. SANCTIONS

Failure to comply with the rules and regulations for media accreditation will result in the immediate withdrawal of accreditation. Further sanctions, such as suspension from reporting on the next Hahnenkamm Races (accreditation) or legal action are reserved by the Organizer or its partners. The jury reserves the right to impose additional sanctions pursuant to the ICR.
