GENERAL CONDITIONS OF ADMISSION (AZO) – Blatt 1/2

- 1.) Event Area (Restricted Area & Spectator Area): The so-called restricted area (racecourse) is defined by a regulation of the municipality of Kitzbühel, specifying the time and location. The spectator area, as part of the officially approved event area, is defined as follows on race days: The spectator area includes the western part of the “Kurpark” near the railway underpass, the area bounded by the Gänsbach stream along its entire course, the railway line, and the line 200 meters west of the Ganslern cable car line, extending to the Seidlalmkopf summit, including the parallel Streif course up to the Walde bottom station. From Gschöss, the area is further defined uphill by lines spaced 200 meters apart on both sides of the racecourses up to the Hahnenkamm starting area, which is marked with ticket control, insofar as it is accessible and not blocked by fences and signs.
- 2.) Caution – Alpine Terrain: The special conditions found in natural, winter terrain are challenging, therefore spectators should adapt their behaviour accordingly and ensure they are properly equipped – an element of sure-footedness is required! The main spectator area is located at the race finish area (ski slope). The racecourse area from start to finish is located in wintry, mountaneous terrain and only partially accessible on foot or with skis (steep terrain). Applicable warning signs and safety barriers must be observed!
- 3.) Access Restriction: Access to the event area on all race days only with valid access authorisation (in the form and restricted time-frames specified by the Organiser). Conditions of the General Terms and Conditions of Ticket Sales (AKB) of the Organiser apply. Additional access restrictions stipulated in the event notice issued by the Municipality of Kitzbühel, as well as ordinances from the event and supervisory authorities – including those made at short notice – are possible and must be observed.
- 4.) Security Checks: The stewards and security staff are authorised to search persons who wish to enter the event grounds for dangerous objects. It is not permitted to carry containers in the form of rucksacks or bags and the like that go beyond personal requirements (with the exception of accredited persons). The security staff are authorised to deny entry to persons who refuse to be searched or who wish to carry objects into the event grounds that could endanger order and security on the event grounds. Obviously intoxicated persons will also be refused entry for security reasons. The same conditions also apply to checks within the event site, with the possible consequence of removal from the event site.
- 5.) Food and Drinks: Bringing food or drinks of any kind, especially alcoholic beverages, into the event grounds, is prohibited! Stewards and security staff are required to check compliance with this order and deny access in the event of any infringements!
- 6.) Advertising Ban: Bringing promotional material of any kind into the event grounds (such as banners, leaflets, newspapers, magazines, unusual clothing etc.) is strictly forbidden. Non-promotional banners may be brought into the event grounds by fans. These, however, must not hinder visibility or endanger the safety of others in any way.
- 7.) Media Rights: All sound, video and film recordings, regardless of their technical nature (e.g. radio, photo, video/film and TV recordings) may only be made and distributed by authorised media-accredited persons. This excludes photography for purely private purposes. Infringements of this regulation will lead to prosecution. By attending the event, spectators consent to appearing in any sound or video recordings which may be produced and published in association with the event. Unmanned aircraft (drones) are prohibited, unless special written permission has been issued by the Organiser.

8.) Environmental Protection: Any damage to, or contamination of the event area or the facilities must be avoided. The following is specifically prohibited in the event area: pulling or cutting off twigs or branches, damaging, fouling or displacing any objects, intentional spillage of water or any other liquids, igniting fires, rockets and fireworks. Paper, food scraps and other waste of all kinds must be deposited in the refuse bins provided. It is forbidden to bring especially environmentally harmful materials *polystyrene in particular* into the event grounds, this also includes unusual sound generators.

9.) Site Control: The entrance areas and grounds are controlled by public and private security bodies (incl. any official video surveillance). Instructions issued by stewards and security staff intended to maintain order and safety must be complied with immediately. In the event of a violation of these admission regulations, the person concerned must identify themselves. Failure to comply with admission regulations or misuse of admission permits will be punished immediately and result in the loss of validity of event access authorization and expulsion from the event grounds.

10.) Liability: The event area is entered at one's own risk and, by doing so, the general and specific risks involved in attending outdoor events in winter are acknowledged. The Organiser disclaims all liability for any damage suffered by the visitor before, during or after the event in direct or indirect connection with the event, except for such damage where liability cannot be excluded. Any infringements of these access regulations may lead to prosecution! Place of fulfilment and exclusive court of jurisdiction is Kitzbühel, Austrian law applies.

11.) Special Provisions: By order of the Municipality of Kitzbühel, the admission of animals is not permitted. Exceptions to this rule are assistance dogs on a lead and wearing a muzzle (assistance dogs are deemed to be guide dogs for the blind, hearing dogs and service dogs in accordance with § 39a of the Federal Disability Act). Service dogs that are carried for official use are also exempt from the ban.
